### General Safety Information

**Warning: The Wesco Hoist Mount Drum Lifter is intended for specific functions. Please adhere to the following instructions to insure safe and proper use.**

- (1) Maximum capacity – 3,000 lbs.
- (2) Do not exceed rated capacity. Injury to persons or property may result from overloading and misuse.
- (3) Never move the unit unless the load is firmly secured.
- (4) Never move loaded unit over people.
- (5) Periodically inspect for damages and loose or missing hardware. If required remove from service and repair.
- (6) Use only genuine Wesco replacement parts when servicing.
- (7) **Only use on Steel 55 Gallon Drums!**

### Warranty Repairs

If the unit does not work properly, contact your dealer or the factory (215-699-7031) for units less than 90 days old.

### Non-Warranty Service

If units are older than 90 days, repairs can be made easily on site with factory supplied parts.

**NOTE:** Do not send units to the factory for service without first obtaining a "Return Merchandise Authorization" (RMA) number from the customer service department. We will not be responsible for merchandise returned without proper authorization.

- (1) Hang lifter ring on crane or hoist hook.
- (2) Place unit on lip of drum
